刘国恩,经济学博士,北大光华管理学院经济学教授,北大光华卫生经济研究院执行院长,北京大学中国卫生经济研究中心主任,博生导师。刘国恩教授曾执教美国南加利福尼亚大学助理教授(1994-1999 助理教授);美国北卡大学副教授(2000-2006,终身职);中国留美经济学会 2004-2005 届主席;以及国际医药经济学会亚太联合会主席。

刘国恩教授目前担任国务院国家医改专家咨询委员会委员,国家人力资源与社会保障部专家委员会委员,中国药物经济学专业委员会主任委员,国际药物经济学会官方期刊《Value in Health》副主编,《中国药物经济学》杂志主编,以及《Journal of Comparative Effectiveness Research》,《Global Handbook of Health Economics》,《European Health Economic Review》编委等。

刘国恩教授目前还担任由 Jeffrey Sachs 领导的联合国《可持续发展方案联盟》(Sustainable Development and Solution Network - SDSN) 领导委员会(Leadership Council) 成员,并作为"人类健康"主题组联席主席,参与在《联合国千年发展目标-MDGs》基础上,研究全球可持续发展的关键挑战,确定共同解决方案,强调最佳做法,为联合国"2015年后的下一个15年发展议程"提供技术支持。

刘国恩教授的研究方向为健康与发展经济学,国家医疗体制改革,以及医药经济学。

Dr. Gordon Liu is a Professor of Economics at Peking University Guanghua School of Management; and Director of PKU China Center for Health Economic Research (CCHER). Prior to Peking University, he served as tenured associate professor at University of North Carolina at Chapel Hill (2000 – 2006); and assistant professor at the University of Southern California (1994 – 2000). He received his PhD in economics from the CUNY Graduate Center in 1991, and post-doctoral training in health economics from Harvard University in 1994.

Dr. Liu sits on the UN "Sustainable Development and Solution Network" (SDSN) Leadership Council, and Co-Chairs the "Health for All" Thematic Group, one of the 12 Thematic Groups for the UN SDSN initiative led by Jeffrey Sachs of Columbia University.

Dr. Liu also serves on the State Council Health Reform Advisory Commission, and is the current president of the Chinese Society for Pharmacoeconomics and Outcomes Research (CSPOR). He was the 2005-2006 President of the Chinese Economists Society, and the founding chair of Asian Consortium for the International Society for Pharmacoeconomics and Outcomes Research. He has served as Co-Editor for the ISPOR official journal of <u>Value in Health</u>, Editor-in-Chief for the <u>China Journal of Pharmaceutical Economics</u>; and he sits on the editorial board for <u>Journal of Comparative Effectiveness Research</u>, <u>Global Handbook of Health Economics</u>, <u>Chinese Journal of Health Economics</u>, and <u>European Health Economic Review</u>. His primary research interests include health and development economics, health reform, and pharmaceutical economics.
